大会经过

1. 大会主席致词

大会主席方炎华在常年会员大会上致词时感谢会员在过去的一年来给予本会最大的支持与合作。他表示,今年是改选年,他即将卸下担任六年的会长的职责。在这段历程中,他感受到了各位董事及会员的鼎力支持与配合。他要特别感谢槟中总永久名誉会长丹斯里陈国平,在过去6年无私的支持、付出和指导。

他在会上也提到,本会去年通过新闻发布会揭发槟州发展机构以低于市价,即6亿4602万718令吉,出售威南峇都交湾第二工业园区558.96英亩的土地,给 UMECH Construction Sdn Bhd,且未经过公开招标。事件发展至今,私下买卖协议已被终止,经过公开招标后,政府可以多进账 1.34亿令吉,证明了商会当初揭发此事,是正确的,并成功维护了全槟人民的利益。

他表示, 商会也非常注重履行企业社会责任。就在今年的七月间, 由丹斯里陈国平发起, 通过内部募捐, 本届51名董事热心捐献, 在短短一个月内筹获并移交555万5888令吉88仙, 捐献给慈济基金会。

他认为今天的大会在没有竞选下选出了新一届的 51 位领导班子, 充分显示会员的精诚团结。新的团队, 加入多位新董事, 为商会带来新的气息。

2. 举行 2024-2027 年董事选举

选举委员会主席陈树楠披露,是届董事选举,因截至8月30日止,提名人数恰好是51名,因此不需进行投票,全部提名者自动中选为董事。

3. 覆准 2023 年 9 月 22 日前期会员大会议案

2023年9月22日前期会员大会议案在黄繼樑提议,骆荣伟附议下,大会一致通过确认覆准。

4. 接纳 2023 年度常年报告书

2023年度常年报告书在骆荣伟提议,林智楝附议下,大会一致通过确认覆准。

5. 接纳 2023 年度经稽查之全年账目报告

2023 年度经稽查之全年账目报告在張家朢提议,黄繼樑附议下,获得大会一致通过予以接纳。

6. 讨论会员提案

大会一致通过接纳由会员提呈之8项提案如下:

- 1) 大会呼吁政府在致力提升土著的经济地位与尊严之际,必须确保不会边缘化 其他族群的利益。
- 2) 大会呼吁政府当局必须严加警惕和打击诈骗,不断以更先进和有效率的方法, 来维护人民对国家金融体系的信心。
- 3) 大会呼吁政府注重改善中小微型企业的经营环境,同时有必要采取更多措施来支持中小微型企业,包括提供低息贷款、税收优惠等政策,帮助解决资金困难。其次,政府应加强对中小微型企业的技术支持和培训,帮助它们提高生产力和竞争力。
- 4) 大会呼吁各级政府部门关注与加强各地基础设施的日常检查与维修工作,确保公众的安全。
- 5) 大会呼吁政府采取行动打击外资企业的低价进口商品倾销,保护本地商家利益。
- 6) 大会关注经济部长最近提出的政府效率承诺法案 (Government Efficiency Commitment Act),并促请政府尽快立法,落实提高公务员效率的承诺。
- 7) 大会呼吁马来西亚检疫及检验服务局(MAQIS)更加重视建立和传达一个清晰和全面的标准操作程序(SOP),以解决相关的监管问题。
- 8) 大会呼吁政府在落实电子发单 (E-INVOICE) 之后,应该检讨目前国内实行的各项税务制度,推出完善、有效率、跟进时代发展与公平的税务制度。

7. 宣布选举结果

选举委员会主席陈树楠在会上宣布,鉴于在8月30日候选人提名截止时,合格之提名者适好51名,即个人/商号/公司候选人42名及商团候选人9名,因此,全部候选人都在无竞争下不战而捷,自动当选为董事。

他表示,这次商会改选在风平浪静、一团和气的气氛下顺利产生,显示新旧董事会成员本着整合团队、精诚合作的协商精神完成领导层更迭的秩序。基本上,新届董事会的变动不大,大部分原任董事继续留任,其中数位退位的董事由新人替代。

槟州中华总商会会长拿督斯里方炎华 2024年度会员大会致词稿 20-09-2024

大家早上好!

首先我要衷心感谢各位董事及会员拨出宝贵的时间,踊跃出席今天的常年会员大会。我也要趁这个机会感谢各位在过去的一年来给予本会最大的支持与合作,谢谢大家。

今年是改选年, 我即将卸下担任六年的会长的职责。在这段历程中, 我感受到了各位董事及会员的鼎力支持与配合。我要特别感谢槟中总永久名誉会长丹斯里陈国平, 在过去 6 年 无私的支持、付出和指导。再次的真心感谢大家!

在过去的岁月里, 我们共同经历了许多挑战和成就, 商会每个任务的顺利完成, 都离不开大家的辛勤付出和智慧。你们的合作与信任, 使得我们的团队能够不断前行, 不断突破。

最近顺利圆满举行的第 17 届世界华商大会,槟中总在执行顾问拿督斯里祝友成的带领下,商会多位董事配合青商团执委及团员,发挥团队精神,为世界华商大会的顺利完成, 作出积极的贡献。

各位董事及会员们,

槟中总成立于1903年,是新马两地最早成立的华商总商会。作为州内代表华商的最高领导组织,槟中总在维护与争取华商权益肩负重大使命。除了提供平台给予会员参与各项商业对接之外,我们也积极和政府当局互动,传达会员商家所面对的各项问题,寻找出合适的解决方案。对于各项攸关社会经济的重大课题,我们皆不亢不卑的提出建言。

我要借这个大会,重提在一年前,即去年10月3日,本会通过新闻发布会,揭发槟州发展机构以低于市价,即6亿4602万718令吉,出售威南峇都交湾第二工业园区558.96英亩的土地给 UMECH Construction Sdn Bhd。这块土地价值数亿令吉,但却没有经过公开招标,PDC 以每平方尺26.53令吉,低于市价出售,而且售地付款期限也延长到4年。

其实, 商会当时是逼于无奈, 才公开揭发 PDC 售地的事件。因为, 早在几个月前, 我们已经发函给予身兼 PDC 主席的槟州首席部长曹观友要求交代这项交易的细节。可惜, 我们所获得的答复却是答非所问。当时, 我们也考虑到州选举近在眼前, 所以, 选择沉默。

我们认为涉及人民切身利益的事件,商会不能置身事外。所以当时商会是在逼不得已的情形下才把事件公开。事件演变到今天,我们看到私下买卖协议在去年10月17日被终止。重新公开招标,共有七家公司竞争这片土地,预计售价为7.8亿令吉,比直接谈判价格6.46亿令吉高出1.34亿令吉或21%。

很显然,通过公开招标,政府可以多进账 1.34亿令吉证明了商会当初揭发此事,是正确的,并成功维护了全槟人民的利益。

我再次强调, 商会做任何事的出发点, 都是在于维护公众和商界的广大利益, 凡涉及损害公众尤其是槟州子民利益的政策, 本会一定挺身而出, 无惧强权, 以维护槟民的共同利益。

履行企业社会责任

除了在商言商,商会也非常注重履行企业社会责任。就在今年的七月间,由丹斯里陈国平发起,通过内部募捐,本届51名董事热心捐献,在短短一个月内筹获并移交555万5888令吉88仙,捐献给慈济基金会。

在我出任会长6年期间,2020年开始面对了冠病疫情,本会为协助槟州政府抗疫,2020年移交了10万片口罩给槟州政府,同时也捐20万令吉给马来西亚中华总商会作为对抗疫情用途。此外,本商会青商团在团长李炯良的带领下,也于2021年捐赠物资包括消毒液和口罩给槟州警察总部。

在后疫情时代,随着各领域开放,本会在去年农历新年复办新春大团拜,吸引了超过2000民众参与,同时在丹斯里陈国平的号召下,本会捐出30万令吉给槟威5个慈善团体。

本会青商团也非常有魄力,举办许多有意义的活动,包括每年新春佳节期间,为槟威两地 B40家庭送上温情,同时也有举办各种活动,如超级青年羽球锦标赛,我感谢李烔良和团 员们积极的带动,继续发掘和栽培年轻企业家。

各位董事及会员们,

在全球经济面临不确定性时,特别是中美贸易战带来的深远影响,东南亚作为一个关键的地缘经济区域,其角色和战略地位变得愈加突出。

1. 不分种族照顾各阶层人民

大会呼吁政府在致力提升土著的经济地位与尊严之际,必须确保不会边缘化其他族群的利益。

案由: 最近首相拿督斯里安华为"2035年土著经济转型蓝图"(PuTERA35)主持推介礼时, 特别强调提升土著的经济地位与尊严。

昌明经济愿景及2030年可持续发展议程应该是以不分种族的照顾各阶层人民。

我国奉行自由市场经济,政府不应该强制干预市场运作。长期扶持土著经济议程,将会削弱竞争力,与市场经济背道而驰。

1. Care for All Segments of People Regardless of Race

We urge the government to ensure that the interests of other communities are not marginalized as it strives to enhance the economic status and dignity of Bumiputra.

Rationale: Recently, Prime Minister Dato' Seri Anwar, at the launching ceremony of the Bumiputera Economic Transformation Plan 2035 (PuTERA35), placed special emphasis on the promotion of the economic status and dignity of the Bumiputra.

We believe that the Bumiputera Economic Transformation Plan and the 2030 Agenda for Sustainable Development should cater to all segments of the population regardless of race.

Our country practices a free market economy and the government should not compulsorily intervene in the operation of the market. Long-term support for the indigenous economic agenda will undermine competitiveness and run counter to the market economy.

2. 严加警惕打击金融诈骗

大会呼吁政府当局必须严加警惕和打击诈骗,不断以更先进和有效率的方法,来维护人民对国家金融体系的信心。

案由: 2023 年全球金融诈骗受害者所承受的损失高达 1 兆美元(约 4.38 兆令吉)。马来西亚官方数据显示,去年有超过 4 万国民总共被骗走约 21 亿令吉,当中有 85%是网络诈骗案。

最近,第二财长拿督斯里阿米尔韩查在推介"国家反欺诈门户"(National Fraud Portal, NFP)时表示,之前的国家诈骗应对中心(NSRC)的流程,需要人手处理,耗费大量时间。

相反的,NFP利用人工智能技术和整合各金融机构的数据分析,能够自动检测可疑交易并快速向相关金融机构验证,反击金融欺诈,进一步改善我国打击网络诈骗的战略。NFP由国家银行、马来西亚支付网络私人有限公司以及金融机构共同推出,目前已有16家金融机构加入,希望未来将有更多金融机构参与,可以加强打击诈骗的有效性。

2. Vigilance in Combating Financial Scams

We urge the government to strictly guard against and crack down on-line scam and fraud, continue to adopt more sophisticated and efficient methods to maintain the confidence of the people in the country's financial system.

Rationale: In 2023, global financial fraud victims suffered losses of up to US\$1 trillion (approximately RM4.38 trillion). Official data from Malaysia shows that more than 40,000 citizens were defrauded of a total of approximately RM2.1 billion last year, 85% of which were online fraud cases.

Recently, during the launch of the National Fraud Portal (NFP), Second Finance Minister Datuk Seri Amir Hamzah said that the previous process of the National Fraud Response Center (NSRC) was time-consuming as it required manpower to handle.

On the contrary, NFP utilizes artificial intelligence technology and integrates data analytics from various financial institutions to be able to automatically detect suspicious transactions and quickly validate them to the relevant financial institutions, countering financial fraud and further improving the country's strategy to combat cyber fraud. NFP was launched by Bank Negara, Malaysian Payment Network Sdn. Bhd. and financial institutions. With 16 financial institutions on board, and it is hoped that more financial institutions will participate in the future, which will enhance the effectiveness of the fight against fraud.

3. 支持中小微型企业的发展

大会呼吁政府注重改善中小微型企业的经营环境,同时有必要采取更多措施来支持中小微型企业,包括提供低息贷款、税收优惠等政策,帮助解决资金困难。其次,政府应加强对中小微型企业的技术支持和培训,帮助它们提高生产力和竞争力。

案由:在我国,中小微型企业 (MSMEs) 在现代经济中扮演着举足轻重的角色。这些企业, 散布在各行各业,特别是服务、制造业、农业、建筑业等领域。它们在推动国家经 济复苏和增长扮演重要作用。

根据马来西亚统计局的数据显示,2023年中小微型企业对国内生产总值(GDP)的 贡献增长5%,达到39.1%,总经济附加值高达6131亿令吉。这一增长率不仅超越了全年国内生产总值3.6%的增幅,还表明中小微型企业在推动国家经济方面的积极作用。

政府应该简化审批流程、减少不必要的行政干预,为这些企业创造更好的发展空间。

3. Support The Development of Small, Medium and Micro Enterprises

We urge the government to focus on improving the business environment for MSMEs, at the same time it is necessary to take more measures to support MSMEs, including the provision of low-interest loans, tax incentives and other policies to help resolve financial difficulties. Secondly, governments should strengthen technical support and training for MSMEs to help them improve their productivity and competitiveness.

Rationale: In our country, Micro, Small and Medium Enterprises (MSMEs) play a pivotal role in the modern economy. These enterprises are scattered in various sectors, especially in the areas of services, manufacturing, agriculture and construction. They play an important role in driving the country's economic recovery and growth.

According to the Department of Statistics Malaysia (DOSM), the contribution of MSMEs to the Gross Domestic Product (GDP) in 2023 grew by 5% to 39.1%, with a total economic value added of RM613.1 billion. This growth rate not only surpasses the annual GDP growth of 3.6%, but also demonstrates the positive role of MSMEs in driving the country's economy.

The government should streamline the approval process and reduce unnecessary administrative interventions to create a better space for these enterprises to grow.

4. 基础设施的维修与安全

大会呼吁各级政府部门关注与加强各地基础设施的日常检查与维修工作,确保公众的安全。

案由:今年八月发生女游客跌入地洞的事件揭示了城市基础设施维护方面存在明显不足。 此外国内多个地区也面临着严重的排水问题,尤其是在雨季,暴雨常常导致多地出 现严重的水灾。

此外,我们的公路也同样令人担忧,不少道路年久失修变得坑洼不平,严重影响了行车安全,增加了交通事故的风险。除了道路的维修,街道、路旁等公众区域的树木,都须定时检查维修。我们希望政府高度重视,采取有效措施,从根本上解决这些问题,为民众创造更加安全、便捷的生活环境。

4. Infrastructure Maintenance and Safety

We urge the government departments at all levels to pay attention to and strengthen the routine inspection and maintenance of infrastructure in various places to ensure public safety.

Rationale: The incident in August this year in which a female tourist fell into a pavement sinkhole revealed glaring deficiencies in the maintenance of urban infrastructure. In addition, several areas of the country face serious drainage problems, especially during the rainy season, when heavy rains often lead to severe flooding in many areas.

Moreover, our roads are equally worrying. Many of them have become potholed after years of disrepair, seriously affecting road safety and increasing the risk of traffic accidents. Apart from road maintenance, trees in public areas such as streets and roadsides have to be inspected and pruned regularly. We hope that the Government will attach great importance to this and take effective measures to tackle these problems at root, so as to create a safer and more convenient living environment for the public.

5. 制止外资企业倾销,保护本地商家利益

大会呼吁政府采取行动打击外资企业的低价进口商品倾销, 保护本地商家利益。

案由: 随着外资企业低价进口商品的涌入, 我国经济受到巨大冲击。特别是中小型企业在激烈的市场竞争中首当其冲, 面临生存压力, 严重影响本地商品在零售和网购市场的销售, 导致本地企业严重亏损甚至倒闭风险。为维护本地经济发展, 政府应果断该采取有效措施,制止不公平的价格倾销行为,为本地企业创造一个公平的市场环境。

根据报道,泰国有超过两千家厂家因为价格倾销行为面临倒闭。因此,该国政府宣布成立工作队,严厉执行条例,维护当地厂家的利益。

5. Stopping Dumping by Foreign Enterprises and Protecting the Interests of Local Businesses

We urge the government to take action against the dumping of low-priced imported goods by foreign companies to protect the interests of local businesses.

Rationale: With the influx of low-priced imported goods from foreign enterprises, our economy has suffered a huge impact. In particular, small and medium-sized enterprises have borne the brunt of the fierce market competition and are facing survival pressure, which seriously affects the sales of local goods in the retail and online shopping markets, leading to the risk of serious losses or even the closure of local enterprises. In order to safeguard local economic development, the government should decisively take effective measures to stop unfair price dumping and create a fair market environment for local enterprises.

According to reports, more than 2,000 manufacturers in Thailand are facing closure due to price dumping. As a result, the country's government has announced the establishment of a task force to strictly enforce regulations and safeguard the interests of local manufacturers.

6. 政府效率承诺法案

大会关注经济部长最近提出的政府效率承诺法案 (Government Efficiency Commitment Act), 并促请政府尽快立法,落实提高公务员效率的承诺。

案由: 经济部长拉菲兹最近在发布经济合作与发展组织(OECD)报告后透露,政府将在今年杪向国会提呈政府效率承诺法案,致力减少各种繁文缛节。该法案将作为衡量工具和基准,帮助政府加快业务流程。部长也承认与邻国比较,在我国注册一家企业的时间较长,而且要遵守的程序繁多,往往要奔走4、5个政府机构。

长久以来, 我国政府行政部门的各种繁文缛节, 加上庞大政府公务员体系的工作效率低下, 都是让国人投诉、埋怨的对象。我们希望随着加薪, 公务员将会提升工作效率与士气。部长主动提出一个新法令来进行监管各政府机构, 减少各种繁文缛节, 是让国人期待的。

6. Government Efficiency Commitment Act

We would like to express our concern about the recent introduction of the Government Efficiency Commitment Act by the Minister of Economy and urged the Government to introduce legislation as soon as possible to implement the commitment to improve the efficiency of the civil service.

Rationale: Following the release of a recent Organization for Economic Cooperation and Development (OECD) report, Minister of Economy YB Rafizi recently revealed that the government will be introducing the Government Efficiency Commitment Bill to Parliament by the end of this year, in an effort to cut down on all sorts of red tape. The bill will serve as a measurement tool and benchmark to help the government speed up business processes. The Minister also acknowledged that in comparison with our neighbouring countries, it takes longer to register a business in this country and there are numerous procedures to comply with, often running through four or five government agencies.

For a long time, the various red tape in our government administration, coupled with the inefficiency of the huge government civil service, have been the subject of complaints and grievances from the people of this country. We hope that with the pay rise, civil servants will improve their efficiency and morale. The Minister's initiative to introduce a new Act to regulate government agencies and to reduce red tape is something that the people of this country are looking forward to.

7. 明确的马来西亚检疫及检验服务局标准操作程序

大会呼吁马来西亚检疫及检验服务局(MAQIS)更加重视建立和传达一个清晰和全面的标准操作程序(SOP),以解决相关的监管问题。

案由:药品进口方面存在重大的监管问题,特别是关于用动物胶原蛋白制成的胶囊所使用的原材料。虽然明胶和胶囊都有 MAQIS 法规规定的直接编码,但这些胶囊的海外生产没有既定编号,因为它与药品生产有关,而明胶生产则有既定编号。

由于没有确定的胶囊编号,制药行业无法申请 MAQIS 批准,从而造成行业内的混乱和误解。尽管有一年的宽限期,但制药行业并不知道这些要求。MAQIS 应采取积极措施,教育制药行业了解这些要求,确保广泛的认识和遵守,特别是考虑到所提供的宽限期。

7. Clear MAQIS's Standard Operating Procedure

We urge MAQIS to emphasize on establishing and communicating a clear and comprehensive Standard Operating Procedure (SOP) to address related regulatory issues.

Rationale: There are significant regulatory issues concerning the import of pharmaceutical products, specifically regarding the raw materials used in capsules made from gelatine, an animal protein derived from collagen. While both gelatine and the capsules have direct codes under MAQIS regulations, however overseas production of these capsules do not have an established number because it is related to pharmaceutical production, whereas gelatine production does have an established number.

The lack of an established number for the capsules prevents pharmaceutical industry from applying for MAQIS approval, causing disruptions and misunderstandings within the industry. Despite being given a one-year grace period, the pharmaceutical industry is unaware of these requirements. MAQIS should undertake proactive measures to educate the pharmaceutical industry on these requirements, ensuring widespread awareness and compliance, particularly given the grace period provided.

8. 检讨各项税务制度

大会呼吁政府在落实电子发单 (E-INVOICE) 之后,应该检讨目前国内实行的各项税务制度,推出完善、有效率、跟进时代发展与公平的税务制度。

案由:目前国内实行多年的各项税务制度皆存有种种弊端,跟不上时代。比方说销售与服务税(SST)的征税程序,除了缺乏透明度,也造成重叠、多重征税的不公平效应(cascading effect)。除外,政府逐步的落实针对性补贴计划,加重了商家的经商成本,应该全面检讨与下调公司与个人所得税。

8. Review of the Tax System

We urge the Government to review and reform the current tax system after the implementation of E-INVOICE, and to introduce a sound, efficient, up-to-date and fair tax system.

Rationale: The tax systems that have been in place in our country for many years are plagued with shortcomings that are out of step with the times. For example, the sales and service tax (SST) collection process lacks transparency and creates a cascading effect of overlapping and multiple taxes. In addition, the gradual implementation of targeted subsidy schemes by the government has increased the cost of doing business, and there should be a comprehensive review and downward adjustment of corporate and personal income tax.

PROCEEDINGS

1. ADDRESS BY THE CHAIRMAN

The Chairman Hong Yeam Wah in his address expressed his gratitude to all PCCC members for their supports and cooperation rendered over the year. He said that this year was the year of re-election and he was about to step down from his duties in this position. During this journey, he had felt the selfless support and guidance of all the directors and members. He also expressed special thanks to PCCC Life Honorary President Tan Sri Tan Kok Ping for his selfless support, contributions, and guidance over the past 6 years.

He also mentioned that last year, the Chamber through a press conference revealed that the Penang Development Corporation (PDC) had sold 558.96 acres of land in Batu Kawan Industrial Park 2 to UMECH Construction Sdn Bhd, a private company in Kuala Lumpur, at a price lower than the market price, i.e., RM646.02million718 without put up for public tender. As the situation had evolved, the private sale agreement had now been terminated. After open tender, the government can now earn an additional RM 134 million which proved that the Chamber was right in exposing the matter in the first place and successfully defended the interests of all Penang people. He also emphasized that the starting point of everything we do was to safeguard the general interests of the public and the business community. Whenever there was a policy that was detrimental to the interests of the public, especially those of the people of Penang, we would definitely stand up for the common interests of the people of Penang, without fear of force.

He stated that the Chamber was highly committed to fulfilling its corporate social responsibility. This past July, under the initiative of Tan Sri Tan Kok Ping, the current 51 Directors actively participated in internal fundraising, successfully raising and donating RM 5,555,888.88 to the Tzu Chi Foundation within just one month.

He mentioned that the new 51-member General Committee was elected without contest in the AGM, fully demonstrated the unity of the members. The new team, with the addition of a number of new directors, brought a new breath of fresh air to the Chamber.

2. <u>ELECTION OF GENERAL COMMITTEE FOR THE 2024-2027 TERM</u>

The Chairman of Election Committee Tan Soo Nam announced that as there were only 51 candidates being nominated for this term of General Committee upon closing of nomination on 30 August 2024, there would be no casting of votes. All the candidates were elected unopposed.

5. <u>ADOPTION OF AUDITED STATEMENT OF ACCOUNTS FOR THE YEAR ENDED</u> 31-12-2023

The audited account for the year 2023 was confirmed and accepted unanimously without any objection as proposed by Cheong Ka Wang and seconded by Ooi Kee Liang.

6. DISCUSSION ON MOTIONS SUBMITTED BY MEMBERS

The meeting adopted the 8 motions submitted by members as follows:

- 1) We urge the government to ensure that the interests of other communities are not marginalized as it strives to enhance the economic status and dignity of Bumiputra.
- 2) We urge the government to strictly guard against and crack down on-line scam and fraud, continue to adopt more sophisticated and efficient methods to maintain the confidence of the people in the country's financial system.

- 4) We urge the government departments at all levels to pay attention to and strengthen the routine inspection and maintenance of infrastructure in various places to ensure public safety.
- 5) We urge the government to take action against the dumping of low-priced imported goods by foreign companies to protect the interests of local businesses.
- 6) We would like to express our concern about the recent introduction of the Government Efficiency Commitment Act by the Minister of Economy and urged the Government to introduce legislation as soon as possible to implement the commitment to improve the efficiency of the civil service.
- 7) We urge MAQIS to emphasize on establishing and communicating a clear and comprehensive Standard Operating Procedure (SOP) to address related regulatory issues.
- 8) We urge the Government to review and reform the current tax system after the implementation of E-INVOICE, and to introduce a sound, efficient, up-to-date and fair tax system.

PENANG CHINESE CHAMBER OF COMMERCE 2024 ANNUAL GENERAL MEETING

Speech by Dato' Seri Hong Yeam Wah, President 20-09-2024

A good morning to all of you!

First of all, I would like to express my gratitude to all General Committee and members for setting aside your precious time to attend today's AGM. I would also like to take this opportunity to thank all of you for your support and cooperation in the past year. Thank you.

This year is the year of re-election and I am about to step down from my duties in this position. During this journey, I have felt the selfless support and guidance of all the directors and members, especially PCCC Life Honorary President Tan Sri Dato' Seri Tan Kok Peng for the past 6 years, thank you sincerely!

In the past years, we have experienced many challenges and achievements together, and every success is inseparable from your hard work and wisdom. Your co-operation and trust have enabled our team to move forward and make breakthroughs.

The 17th World Chinese Entrepreneurs Convention (WCEC) was held successfully recently. Under the leadership of PCCC Executive Adviser Dato' Seri Choot Ewe Seng, a number of PCCC Directors, in conjunction with YES Committee and members, played their role as a team player in the WCEC and contributed positively to the success of the WCEC.

Our fellow Directors and Members,

The Chamber was established in 1903 and it was the earliest Chinese Chamber of Commerce in Malaysia and Singapore. As the highest representative organization of the Chinese business community in the state, the Chamber has an important mission to protect and fight for the rights and interests of the Chinese business community. Apart from providing a platform for our members to engage in business matchmaking, PCCC is also a bridge for dialogue with the government, communicating the problems faced by members of the business community to find appropriate solutions. We have made suggestions in a humble manner on all major issues concerning social economy.

I would like to take this opportunity to recall that one year ago, on 3 October 2023, the Chamber, through a press conference, revealed that the Penang Development Corporation (PDC) had sold 558.96 acres of land in Batu Kawan Industrial Park 2 (BKIP2) to UMECH Construction Sdn Bhd at a price below market value, i.e., RM646.02 million 718 ringgit and that the land, which was valued at hundreds of millions of ringgit, was sold to UMECH Construction Sdn Bhd without a public tender process and the payment period for land sales has been extended to 4 years.

In fact, the Chamber had no choice but to expose the PDC land sale publicly at that time. A few months earlier, we had already written to Penang Chief Minister YAB Chow Kon Yeow, who is also the Chairman of PDC, asking for an explanation of the details of the deal. Unfortunately, the reply we received was irrelevant. At that time, we chose to remain silent in view of the upcoming state elections.

We believe that the Chamber cannot remain aloof from an incident that involves the immediate interests of the people. That is why the Chamber made the incident public at that time only as a last resort. As the incident has evolved to the present day, we can see that the private sale and purchase agreement was terminated on 17 October last year. A total of seven companies competed for the land in a fresh public tender, with an estimated selling price of RM780 million, which is RM134 million or 21 per cent higher than the directly negotiated price of RM646 million.

Obviously, the fact that the government was able to pocket an additional RM134 million through the open tender proves that the Chamber was right in exposing the matter and succeeded in defending the interests of the people of Penang.

I would like to emphasis once again that the Chamber's starting point in everything we do is to safeguard the general interests of the public and the business community. Whenever it comes to policies that are detrimental to the interests of the public, especially those of Penang's people, the Chamber will surely stand up to them, without fear of force, in order to safeguard the common interests of the people of Penang.

Fulfilment of Corporate Social Responsibility

Apart from doing business, the Chamber also places great emphasis on fulfilling its corporate social responsibility. In July this year, Tan Sri Tan Kok Ping initiated an internal fundraising campaign to raise and hand over RM5,555,888.88 to the Buddhist Tzu Chi Merits Society Malaysia in just one month through the enthusiastic donations of the 51 Directors of the Chamber.

During my 6-year tenure as President, we were faced with the COVID-19 pandemic in 2020. In order to assist the Penang State Government in the fight against the pandemic, we handed over 100,000 masks to the Penang State Government in 2020 and donated RM200,000 to the Associated Chinese Chambers of Commerce & Industry of Malaysia (MICCI) for the fight against the pandemic. In addition, the Chamber's Young Entrepreneur Section (YES), led by its Chairman Mr. Lee Toong Leong, donated disinfectant and masks to the Penang State Police Headquarters in 2021.

In the post epidemic era, with the opening up of various sectors, the Chamber resumed its Chinese New Year Open House 2023 last year on the Lunar New Year's Day, which attracted the participation of more than 2,000 people, while at the same time, under the call of Tan Sri Tan Kok Ping, the Chamber donated RM300,000 to five charitable organizations in Penang.

PCCC YES is also very enterprising in organizing many meaningful activities, including the annual Chinese New Year festivities to bring warmth to the B40 families in Penang and Province Wellesley, as well as various events such as the Super Youth Badminton Championships. I would like to thank Mr. Lee Toong Leong and YES members for actively driving the group to continue to identify and cultivate young entrepreneurs.

Therefore, while facing challenges, we should also see opportunities. Our geographical advantages and strategic location enable us to play an important role in the global economy. We should enhance the resilience and competitiveness of the overall economy by strengthening regional cooperation, promoting investment and fostering science, technology and innovation.

Our ports, such as the Port Klang, are among the busiest in South-East Asia and ranked as the 11th busiest in the world, providing efficient logistical support for trade within and outside the region. We should take full advantage of this by further upgrading our infrastructure development and modernizing our port facilities to ensure that we can better serve the global market.

New Leadership

Today's Annual General Meeting has successfully elected a new leadership team of 51 members. The new team, which was successfully elected without any election, fully demonstrated the unity of the members. The new team, with the addition of a number of new Directors, brings a new breath to the Chamber. This is a good sign. I would also like to thank the outgoing Directors for their dedication to the Chamber in the past, which is a role model for all of us to follow, and they will continue to show their interest and support to the Chamber's activities.

Looking ahead, the Chamber will continue to be steadfast in upholding our philosophy and speaking out, and we firmly believe that through the concerted efforts of all of us, Penang will be able to realize a brighter tomorrow.

大会主席拿督斯里方炎华在常年会员大会上致词时感谢会员在过去的一年来给予本会最大的支持与合作。他表示,今年是改选年,他即将卸下担任六年的会长的职责。在这段历程中,他感受到了各 位董事及会员的鼎力支持与配合。他要特别感谢槟中总永久名誉会长丹斯里陈国平,在过去 6 年给予无私的支持、付出和指导。

随后,进行董事改选,选举委员会主席拿督陈树楠宣布截至8月30日止,提名人数恰好是51名,即个人/商号/公司候选人42名及商团候选人9名,因此,全部候选人都在无竞争下不战而捷,自动当选为董事。

槟州中华总商会复选会议

2024年9月20日复选后

昌明大马反贪座谈会

槟中总青商团与马来西亚反贪污委员会及亚依淡区州议员黄顺祥于2024年10月5日(星期六)上午9时至1时在陈国平厅联合举办昌明大马反贪座谈会。座谈会一开始先由反贪会官员 Tuan Rezuan bin Sharif 为大家讲解贪污的形式和罪行。随后由反贪污委员会社会教育组副主任 Tuan Samsul bin Salip 及槟岛市政厅秘书蒋志鸿为大家分享如何杜绝贪污,亚依淡选区联络官黄金渟是座谈会的主持人。

反贪污委员会社会教育组副主任 Tuan Samsul bin Salip 呼吁公众不要置身事外,而选择不举报所看到的贪污事件。他表示,公众不需要担心做出举报后面临威胁,因为反贪会将在证人保护法令下保护举报者及证人。

活动当天约有65人出席聆听,旨在提高民众对贪污犯罪的觉醒意识,并巩固与反贪会之间的合作。

砂拉越中华总商会青商团莅访

砂拉越中华总商会青商团在团长胡文泰律师的带领下,一行19人于2024年10月15日(星期二)下午5时15分莅访槟中总,获得团长李烔良及执委们的接待。

双方相互交流,旨在加强两地青商团之间的互动与合作,进一步拓展两地的商机。

收视财政预算案公布之现场直播

槟中总执行董事于 2024年 10月 18日(星期五)下午 4时,在陈国平厅收视财政部长公布国家财政预算案 之现场直播,并在财政部长宣布过后,即对预算案作出评估及向报界发表意见,以反映槟中总之观点和 见解。 槟州中华总商会今天形容 2025年国家财政预算为中规中矩,没有重大加税,没有带来压力。

2025 年财政预算案主题为"昌明经济、繁荣国家、幸福人民"(Ekonomi MADANI, Negara Makmur, Rakyat Sejahtera),将注重在 3 个短期优先事项以实现昌明经济框架,即提高顶限(调整经济结构、使其更有价值、更具竞争力)、提高门槛(改善人们的生活质量),以及加强治理和公共服务。

安华宣布总拨款达 4210 亿令吉,是历年来拨款额最高的预算案。4210 亿令吉当中,其中行政开支占3350 亿、发展开支占860 亿、并有20 亿用于应急储蓄。这笔4210 亿令吉的总拨款,较2024年的3938 亿令吉总拨款,增加了272 亿令吉。发展开支只占据20%,明显不足。我们认为,当前政府组织结构繁杂,公务员体系庞大,导致日常行政开支过高,严重影响了发展资金的调动。对此,我们呼吁政府应逐步精简组织结构,减少冗员,优化资源配置。

针对 2025 年财政预算案的评论中,槟中总关注到首相宣布不会进行新的大型工程计划,相反的会专注于对人民有利及支撑工业发展计划。关于槟州,共有三项建设在预算案中提到,轻快铁计划、国际机场扩建以及峇都加湾第三工业区。

在这方面,槟中总呼吁政府可以尽快施工,在最快时间内完成,让这三个大计划为槟州发展带来实际效益。此外,槟中总也感谢首相在威省设立一站式 UTC 服务。

首相宣布从明年二月开始,最低薪资从目前的马币一千五百,调高到一千七百。槟中总会长拿督斯里祝友成希望政府在调整最低薪资的决定要渐进式的进行。会长强调:"我们希望政府可以考虑到中小型工商业的困境,任何调高最低薪资的决定,应该以软着陆方式进行,避免造成过重负担。"

此外, 祝友成也说:"槟中总非常关注首相在预算案中提到要把销售及服务税的征税范围扩大至包括商业服务, 收费金融服务等业务。我们希望政府在实行扩大征税范围之前与相关业者交流沟通, 提供细节, 达到双赢, 避免影响商界的正常业务发展。"

值得关注的是,首相兼财政部长拿督斯里安华也宣布政府预计在2025年中落实RON95汽油针对性补贴措施,并强调85%人民仍可享有相关补贴。

针对这点, 槟中总认为政府的出发点无可厚非。但是, 我们希望政府在执行时要做到公平合理, 减低工商界的痛苦。同时, 在执行过程中的任何偏差, 必须适时的调整。

最后, 槟中总认为这项 2025 年财政预算案的整体策列方向是正确的, 希望政府各级官员认真执行任务, 造福国家人民。

槟州民主行动党莅访

The seminar invited Mr. Julian Neo, Managing Director of DHL Express Malaysia and Brunei, facilitators Mr. Bryan Lim and Mr. Calvin Oh to share insights on how logistics impacts customer satisfaction, how to expand international business through E-Commerce, knowledge of logistics and customs and the significance of compliance for the long-term stability and development of businesses. Meanwhile, the seminar also invited the representative of Amazon Singapore Ms. Martina to introduce cross-border E-Commerce and share insights on the scale of the North American market and an overview of overseas operations. Gazumbo Island Cleanup Mission and Rescue Stray Dogs

The Gazumbo Island, located next to the Penang Bridge, boasts the largest seagrass bed in the Strait of Malacca. However, climate change and debris drifting in from various sources had caused severe pollution on the island. PCCC YES together with the Penang Island City Council (Public Health and Municipal Services Division), the Royal Malaysian Navy Volunteer Reserve and members of the Marine Police went to the island to conduct a cleaning campaign, collecting a total of 1,255 kilograms of waste including 1,015 kilograms of plastic waste.

The team initially planned to rescue 12 abandoned stray dogs on the island and bring them back to Penang but they were unsuccessful. The stray dogs were frightened of humans and ran into the forest as soon as they saw anyone approaching. However, they would arrange to come back again with cages to trap stray dogs, sterilize them and offer them for adoption.

The goal was to complete the donations within one month time frame, aiming to deliver the fund to Tzu Chi by next month.

PCCC Charity Fund Committee Chairman Dato' Loh Eng Wee hoped that through this donation, they could bring warmth and hope to more people in need. At the same time, they hoped this effort would inspire more entrepreneurs to contribute to society.

The Director of Tzu Chi Group of Entrepreneurs Dr. Lee Ching Hoe shared the Tzu Chi's charitable mission and philosophy during the event. He mentioned that Tzu Chi began its operations in Malaysia in 1996 and established Buddhist Tzu Chi Merits Society Malaysia in the same year. Currently, there were 170 branches across the country with a membership of over one million and more than 3,000 volunteers. AFTER THE INCOMING GENERAL COMMITTEE MEETING ON 20 SEPTEMBER 2024

Malaysia Madani Anti-Corruption Symposium

PCCC YES together with the Malaysian Anti-Corruption Commission (SPRM) and Air Itam State Assemblyman Joseph Ng Soon Siang jointly organized Malayia Madani Anti-Corruption Symposium on Saturday, 5 October 2024 from 9am to 1pm at Tan Kok Ping Hall.

At the beginning of the seminar, the officer Tuan Rezuan bin Sharif provided an explanation of the forms and crimes of corruption. Then followed by Tuan Samsul bin Salip, the Deputy Director of the Social Education Division of the Anti-Corruption Commission and Mr. Cheong Chee Hong, the Secretary of the Penang Island Municipal Council, who shared insights on how to prevent corruption. The seminar was chaired by the moderator Ms. Ng Kim Theng, the liaison officer for the Ayer Itam constituency.

Tuan Samsul bin Salip urged the public not to remain indifferent and to report any observed corruption incidents. He emphasized that the public should not fear retaliation after making a report, as the Anti-Corruption Commission would protect whistleblowers and witnesses under the Witness Protection Act 2009.

There were about 65 people attended the event, which aimed to raise public awareness of corruption crimes and strengthen cooperation with the Anti-Corruption Commission.

They were received by Chairman Mr. Lee Toong Leon and YES committee members.

Both parties engaged in mutual exchanges to strengthen interaction and collaboration between the young entrepreneurs as well as further expanding business opportunities.

Live Telecast Viewing of Budget Speech

PCCC Executive Committee Members organized a live telecast viewing of the national budget speech by the Finance Minister on Friday, 18 October 2024 at 4:00pm at Tan Kok Ping Hall to evaluate the budget and thereafter issued a press release to reflect the Chamber's views and comments.

Penang Chinese Chamber of Commerce today described the 2025 Budget as moderate, with no significant tax increases and believed that it will not impose additional burden on the costs of doing business.

The theme of the 2025 National Budget is Ekonomi MADANI, Negara Makmur, Rakyat Sejahtera. It will focus on three short-term priorities to achieve the MADANI economic framework, i.e. To raise the ceiling (in terms of restructuring the economy towards greater competitiveness and higher value-added activities), To raise the floor (in terms of improving quality of life and inclusiveness of opportunities); and to strengthen governance and public delivery.

Anwar has announced an allocation of RM421 billion for Budget 2025, marking the highest budget allocation in the history. Out of the RM421 billion, RM335 billion is allocated for administrative expenditure, RM86 billion for development expenditure and RM2 billion for contingency reserves. This total allocation of RM421 billion represents an increase of RM27.2 billion compared to the RM393.8 billion allocated in 2024. Development expenditure only occupies 20%, which is clearly insufficient. We believe that the current government administrative structure is overly complex, and the large scale of civil service system is bloated leading to excessively high administrative expenditure, which severely affects the allocation of development funds. In this regard, we urge the government to gradually streamline the organizational structure, downsize the bloated civil service, and optimize resource allocation.

In the comments on the 2025 Budget, PCCC noted that the Prime Minister announced that no new mega projects will be undertaken. On the contrary, the focus will be on initiatives that benefit the people and support industrial development. The budget highlights three specific projects for Penang including LRT project, the expansion of the international airport and the development of the Batu Kawan Industrial Park 3.

In this regard, PCCC urges the government to commence construction as soon as possible and complete these three major projects in the shortest time, so that these three major projects can bring tangible benefits to the development of Penang. Additionally, the Chamber expressed gratitude to the Prime Minister for establishing a UTC – one stop service centre in Seberang Perai.

The Prime Minister announced that the minimum wage will be raised from the current RM1,500 to RM1,700 effective from Feb 1, 2025. PCCC President Dato' Seri Choot Ewe Seng hopes that the government's decision to adjust the minimum wage will be implemented gradually. He emphasized, "We hope the government can take into account the difficulties faced by SMEs. Any decision to raise the minimum wage should be carried out in a soft-landing manner to void causing sudden heavy burden on the SMEs."

In addition, Dato' Seri Choot Ewe Seng also said: "The Penang Chinese Chamber of Commerce is very concerned about the Prime Minister's mention in the budget that the scope of the Sales and Services Tax (SST) will be expanded to include business services, fee-based financial services, and other sectors. We appeal to the government to communicate with the relevant stakeholders before expanding the tax scope, providing

more details in order to achieve a win-win situation and avoid adverse impact on the normal business operations."

It is worth noting that the Prime Minister cum Finance Minister Datuk Seri Anwar also announced that the government expects to implement targeted subsidies for RON 95 petrol by mid-2025 in an effort to maintain the subsidy on petrol, emphasizing that 85% of the population will still be entitled to the subsidy.

In this regard, PCCC acknowledges that the government's intentions are understandable. However, we hope that the Government will be fair and reasonable in its implementation to minimize the burden of the business community. At the same time, any deviations during the implementation process must be adjusted in a timely manner

Finally, the Chamber believes that the overall direction of the Budget 2025 is correct and hopes that government officials at all levels will diligently carry out their responsibilities for the benefit of the nation and its people.

A delegation of 13 people from the newly appointed leadership of the Penang Democratic Action Party (DAP) Penang led by Chairman YB Mr. Steven Sim Chee Keong paid an official visit to PCCC on Saturday, 26 October 2024. They were warmly received by PCCC Executive Advisor Dato' Seri Hong Yeam Wah, Advisor Dato' Tan Hiang Joo, President Dato' Seri Choot Ewe Seng and PCCC Executive Committee Members.

During the dialogue session, both parties discussed the topics including the recently proposed fiscal budget, minimum wage policies, education, and human capital development. They also exchanged ideas on potential future collaborations between the Penang DAP and PCCC. President Dato' Seri Choot Ewe Seng expressed his appreciation for the exchange and hoped for more similar engagements in the future to foster information sharing and provide collective insights to drive Penang's economic and social development.

Courtesy Visit by H. E. Luis Javier Campuzano Piña, Ambassador of Mexico to Malaysia

The Ambassador of Mexico to Malaysia H. E. Luis Javier Campuzano Piña paid a courtesy visit to PCCC on Friday, 15 November 2024 at 10am and received by PCCC Deputy President Dato' Lim Chee Tong and Executive Committee Members. The purpose of this visit was to deepen bilateral relations between Mexico and Malaysia, foster people-to-people connections, and explore new areas of collaboration for the mutual benefit of both countries.

Automated External Defibrillator (AED) Handover Ceremony @ Taman Bukit Panchor Basketball Court

PCCC handed over an Automated External Defibrillator (AED) to the Bukit Panchor Community Association on Sunday, 17 November 2024. This AED would serve as a life-saving device for residents in case of emergencies, contributing to creating a safer living environment for the community. During the day, Jawi State Assemblyman YB Mr. H'ng Mooi Lye was invited to officiate the AED handover ceremony. The event cost was funded by a grant from MBSP Councillor Mr. Benson Neoh Kah Wei.

Sharing Session by Tzu Chi

PCCC General Committee Members, YES Committee Members and members attended the Sharing session by Tzu Chi on Sunday, 24 November 2024 at 9am at Tan Kok Ping Hall. The Deputy CEO of Tzu Chi Dr. Rey Sheng Her delivered a talk on the theme of "Philanthropic Economic". He shared the concept of pursuing mutual prosperity and goodwill between businesses and society, based on the principles of altruism and harmony. There were about 80 people present during the day.

Courtesy Visit by the Delegation from Wuhu Municipal People's Government

A delegation of 7 people from Wuhu Municipal People's Government led by Vice Mayor Mr. Xiang Jihui paid a courtesy visit to PCCC on Thursday, 5 December 2024 at 2pm. They were received by Executive Advisor Dato' Seri Hong Yeam Wah, Deputy President Dato' Lim Chee Tong and Executive Committee Members.

The purpose of this visit was to introduce Wuhu as a sub-central city of Anhui Province and its position as the second-largest economic city. The delegation aimed to showcase Wuhu's advantages in regional economy, industrial development, and urban construction while exploring potential cooperation with Penang and related sectors.

Island Cleanup Day at Pulau Gazumbo and Pulau Jerejak

PCCC YES together with the Penang Island City Council (MBPP), students and faculty from Universiti Teknologi MARA (UiTM) Penang branch, Marine Police, KD Sri Pinang and volunteers participated the Island cleanup initiatives on Saturday, 7 December 2024 at 7am. They took the boat to Pulau Gazumbo and Pulau Jerajak and collected a total of 728 kilograms of waste, including 438 kilograms of plastic, 140 kilograms of aluminum cans and glass bottles, and 150 kilograms of non-recyclable waste within 3 hours.

Opening Ceremony of Recycle Centre at Lintang Macallum Dua

In order to promote the waste segregation implemented by Penang State Government, PCCC collaborated with Penang Island City Council (MBPP) and the assemblymen Wong Yuee Harng, to set up a waste segregation centre at Lintang Macallum Dua with a fund allocated from MBPP Councillor Mr. Chen Wooi Teong. The opening ceremony was held on Tuesday, 10 December 2024 at 4:30pm. Tzu Chi was the strategic partner for this initiative and would arrange the volunteers to handle the recycle items on a weekly basis. PCCC President Dato' Seri Choot Ewe Seng, General Committee Members and YES Committee Members attended the opening ceremony to witness the launching of this environmental project.

NOTES TO THE FINANCIAL STATEMENTS - 31 DECEMBER 2024

1. PRINCIPAL ACTIVITIES

The principal activities of the Association are to improve and develop trade and industry, collect and distribute commercial information and issue certificates of authentication, arbitrate and settle trade and industrial disputes, collect and compile trade statistics and hold trade exhibitions and sponsor charitable works. There have been no significant change in the nature of these activities during the financial year.

2. ACCOUNTING POLICIES

2.1 Basis of Accounting

The financial statements of the Association have been prepared under the historical cost convention in accordance with the MASB Approved Accounting Standards in Malaysia for Private Entities in all material respects.

2.2 Depreciation

Depreciation of property, plant and equipment is on a straight line basis calculated to write-off the cost over their expected useful lives.

The principal annual rates used for this purpose are as follows:

Furniture and fittings	10%
Office equipment	10%
Office renovation	20%
Computer	40%
Freehold land and building	2%

2.3 Subscriptions

Subscriptions are taken up on cash basis.

2.4 Rental Income

Rental income is accounted for on accrual basis.

2.5 Fixed Deposit Interest Received

Fixed deposit interest is recognised on cash receipt basis.

2.6 Charitable Funds

Charitable funds consist of unrestricted funds and restricted funds.

Unrestricted funds is a general fund that is available for use at the Executive Committee's discretion in furtherance to the objectives of the Association Restricted funds are subject to particular purposes imposed by the donor or by nature of appeal. They are not available for use in other Association's activities or purposes.

2.7 Income Tax

Income tax on the profit or loss for the year comprises of current and deferred tax. Current tax is the expected amount of income taxes payable in respect of the taxable profit for the year and is measured using the tax rates that have been enacted at the balance sheet date.

Deferred tax is provided for, using the liability method, on temporary differences at the balance sheet date between the tax bases of assets and liabilities and their carrying amounts in the financial statements. In principle, deferred tax liabilities are recognised for all taxable temporary differences and deferred tax assets are recognised for all deductible temporary differences, unused tax losses and unused tax credits to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, unused tax losses and unused tax credit can be utilised. Deferred tax is not recognised if the temporary difference arises from goodwill or negative goodwill or from initial recognition of an asset or liability in a transaction which is not a business combination and at the time of the transaction, affects neither accounting profit nor taxable profit.

2.8 Cash and Cash Equivalent

Cash and cash equivalents include cash in hand and at bank which have an insignificant risk of changes in value, net of outstanding bank overdrafts, if any.

2.9 Receivables

Receivables are carried at anticipated realisable values. Bad debts are written off when identified. An estimate is made for doubtful debts based on a review of all outstanding amounts as at the balance sheet date.

3.0 Payables

Payables are stated at cost which is the fair value of the consideration to be paid in future for goods and services rendered.
