Eligible Applicants

Citizens of Malaysia holding a valid passport who are:

- Senior executive level business people (eg. Chairman, Board of Directors, Chief Executive Officer, Managing Director, President, Vice President, Regional Director or the equivalents).
- Required/need to travel frequently to APEC economies for trade and investment purposes.
- Business entity (which the applicant represents) must be well-established and well-credentialed in terms of its international trade and investment activities and registered with Companies Commission of Malaysia.
- Professionals being persons who possess necessary professional qualifications, experience and/or expertise which have been duly recognised by the professional bodies in Malaysia and registered with those respective professional bodies; and are carrying out relevant professional activities in APEC economies.
- Senior Government Officials who need to travel frequently to APEC economies.
- Senior office bearers of trade and industry organisations and professional bodies.

Non Eligible Applicants

- Applicants who have criminal records with the Royal Malaysia Police or in the 'Black List' of the Immigration Department of Malaysia;
- Dependent spouses or children of the applicant;
- Athletes, news correspondence, entertainers, musicians, artists, or people engaged in similar occupation;
- People seeking employment overseas; and
- People intending to engage in paid employment overseas.
